### **UNFINISHED BUSINESS:**

Vice-Chairman Ehrhart made a motion to accept the Election of Officers policy, as proposed. Seconded by Commissioner Jodlowski and carried.

Vice-Chairman Ehrhart made a motion to accept the Article 14 Apparatus Vehicle Operations policy, as proposed. Seconded by Commissioner Dixon and motion was carried.

Vice-Chairman Ehrhart made a motion to accept the Operations Plan in the Event of Certain Declared Public Health Emergencies, as proposed. Seconded by Commissioner Dixon and carried.

Commissioner McNamara made a motion to set the date of Monday, November 27, 2022 from 9am to 12pm, to have Nancy Jackson review the rolls for the upcoming Commissioner election. Seconded by Commissioner Dixon and carried.

Commissioner Dixon made a motion to purchase 36 lengths of 2" hose for \$249.00 each, not to exceed \$9,000.00. These are to be delivered and paid for in 2023. Seconded by Commissioner Jodlowski and carried.

Commissioner McNamara made a motion to sell the blowup light and generator to East Fishkill Police Department for \$1.00. Seconded by Vice-Chairman Ehrhart and carried.

Commissioner Jodlowski made a motion to authorize the Treasurer to transfer \$100,000.00 from NYClass General Fund to Tompkins Checking. Seconded by Vice-Chairman Ehrhart and carried. Commissioner Dixon abstained.

Commissioner Dixon advised that Board that he and Secretary Kaye have begun looking into having BLS transports billed to patient insurance companies by an outside vendor. They have contacted and met with one vendor but will be looking into others. The process of obtaining an NPI number is the first step and Secretary Kaye will be looking into that.
