#### **MEETING OPENED:**

THE EAST FISHKILL BOARD OF FIRE COMMISSIONERS HELD THEIR RE-ORGANIZATIONAL MEETING FOR THE YEAR 2021 AT DISTRICT HEADQUARTERS. SECRETARY KAYE CALLED THE MEETING TO ORDER AT 7:51 PM

### **ORGANIZATION FOR YEAR 2021:**

**CHAIRMAN:** SECRETARY KAYE REQUESTED NOMINATIONS FOR CHAIRMAN OF THE BOARD. COMMISSIONER DIXON MADE A MOTION TO APPOINT COMMISSIONER McNAMARA AS CHAIRMAN OF THE BOARD. COMMISSIONER JODLOWSKI SECONDED AND MOTION CARRIED.

VICE CHAIRMAN: CHAIRMAN McNAMARA ASKED FOR NOMINATIONS FOR THE POSITION OF VICE-CHAIRMAN. COMMISSIONER DIXON MADE A MOTION TO APPOINT COMMISSIONER SHULTIS AS VICE-CHAIRMAN. SECONDED BY COMMISSIONER JODLOWSKI. MOTION CARRIED.

**SECRETARY/TREASURER:** COMMISSIONER EHRHART MADE A MOTION TO REAPPOINT JULIE J. BEYER AS SECRETARY/TREASURER AT A YEARLY SALARY OF \$56,373.04. VICE-CHAIRMAN SHULTIS SECONDED THE MOTION. ALL WERE IN FAVOR. MOTION CARRIED.

**DEPUTY TREASURER:** COMMISSIONER EHRHART MADE A MOTION TO REAPPOINT KATHLEEN A. KAYE AS THE DEPUTY TREASURER/SECRETARY AT A YEARLY SALARY OF \$44,889.10 AND VICE-CHAIRMAN SHULTIS SECONDED IT. ALL WERE IN FAVOR. MOTION CARRIED.

**LABORER:** COMMISSIONER EHRHART MADE A MOTION THAT DAVID L. PALIN, THE DISTRICT'S PERSON IN CHARGE OF RADIOS AND KNOX BOXES, WOULD BE PAID AT AN HOURLY RATE OF \$19.50 AND VICE-CHAIRMAN SHULTIS SECONDED. ALL WERE IN FAVOR. MOTION CARRIED.

**PUBLICATION OF NOTICES:** ON A MOTION BY COMMISSIONER EHRHART AND SECONDED BY VICE-CHAIRMAN SHULTIS, THE POUGHKEEPSIE JOURNAL WAS DESIGNATED AS THE OFFICIAL PUBLICATION OF THE FIRE DISTRICT FOR NOTICES. ALL WERE IN FAVOR. MOTION CARRIED.

**OFFICIAL DEPOSITORY:** ON A MOTION BY COMMISSIONER EHRHART AND SECONDED BY VICE-CHAIRMAN SHULTIS, TOMPKINS MAHOPAC NATIONAL BANK AND NYCLASS WERE DESIGNATED AS THE OFFICIAL DEPOSITORIES FOR THE EAST FISHKILL FIRE DISTRICT. COMMISSIONER DIXON ABSTAINED. MOTION CARRIED.

**DESIGNATION OF RESERVE FUNDS:** ON A MOTION BY COMMISSIONER JODLOWSKI, SECONDED BY VICE-CHAIRMAN SHULTIS, THE RESERVE FUNDS WERE DESIGNATED AS FOLLOWS:

RESERVE FUND FOR THE PURCHASE OF MAJOR EQUIPMENT WITH A MAXIMUM LIMIT OF \$5,000,000.00

RESERVE FUND FOR BUILDING AND LAND ACQUISITION WITH A MAXIMUM LIMIT OF \$5,000,000.00.

ALL IN FAVOR. MOTION CARRIED.

TRAVEL EXPENSES: ON A MOTION BY COMMISSIONER JODLOWSKI AND SECONDED BY VICE-CHAIRMAN SHULTIS, MILEAGE WILL BE PAID AT THE RATE OF .56 CENTS PER MILE, ALL REGISTRATIONS MUST BE SUBMITTED ONE MONTH PRIOR FOR APPROVAL BY THE BOARD, AND THE MAXIMUM REIMBURSEMENT PER DAY FOR MEALS WILL BE \$50 UNLESS OTHERWISE APPROVED. RECEIPTS MUST BE TURNED IN WITHIN 45 DAYS OF THE EVENT FOR REIMBURSEMENT TO MEMBERS. DISTRICT VAN 39-68 RULES REMAIN THE SAME. TRUCK RULES FOR 39-69 AND 39-96 REMAIN THE SAME. ALL WERE IN FAVOR. MOTION CARRIED.

AT THIS POINT, THE RE-ORGANIZATIONAL PORTION OF THE MEETING WAS COMPLETE AND THE REGULAR MEETING CONTINUED.

CHAIRMAN McNAMARA OPENED THE ONLY BID THAT WAS RECEIVED FOR THE 2021 FORD F550 MINI PUMPER. IT WAS FROM MARCO EQUIPMENT SALES, LLC IN THE AMOUNT OF \$291,095.00. THIS BID WAS ACCEPTED AND WILL BE FORWARDED TO THE TRUCK COMMITTEE FOR FINAL APPROVAL. COMMISSIONER EHRHART REMINDED THE BOARD THAT THERE SHOULD BE A CLAUSE IN THE CONTRACT STATING THAT IF THE VENDOR GOES OVER THEIR SCHEDULED BUILDING TIMEFRAME THERE WILL BE RAMIFICATIONS. THE CONTRACT WILL BE REVIEWED.

VICE-CHAIRMAN SHULTIS MADE A MOTION TO APPROVE PAYABLES AS PRESENTED, TO INCLUDE \$6,500.00 TO DONALDSON CONSTRUCTION AND \$2,900.00 TO PERRI VERONE ROOFING. COMMISSIONER EHRHART SECONDED THE MOTION. ALL WERE IN FAVOR. MOTION CARRIED.

THE BANK STATEMENTS WERE OPENED BY CHAIRMAN McNAMARA AND EVERYTHING APPEARS TO BE IN ORDER.

NEW BUSINESS: ON A MOTION BY COMMISSIONER JODLOWSKI AND SECONDED BY VICE-CHAIRMAN SHULTIS \$100,000 WILL BE TRANSFERRED FROM NYCLASS GENERAL FUND TO MAHOPAC GENERAL FUND FOR PAYABLES, \$15,000 WILL BE TRANSFERRED FROM NYCLASS GENERAL FUND TO MAHOPAC BUSINESS BUILDER, \$20,000 FROM NYCLASS RESERVE BUILDING AND LAND TO MAHOPAC RESERVE BUILDING AND LAND AND \$25,000 FROM NYCLASS MAJOR EQUIPMENT TO MAHOPAC RESERVE MAJOR EQUIPMENT. COMMISSIONER DIXON ABSTAINED. ALL OTHERS VOTED IN FAVOR AND MOTION CARRIED.

### **CHIEF REPORTS:**

DISTRICT CHIEF LACALAMITA GAVE THE BOARD COPIES OF UPDATED MINIMUM TRAINING STANDARDS AND BEST OPERATIONAL PRACTICES THAT HE WOULD LIKE TO HAVE APPROVED. THE BOARD WILL REVIEW THESE CHANGES. COMMISSIONER DIXON MADE MOTION, AT THE REQUEST OF CHIEF LACALAMITA, THAT THE AMBULANCE AND ANOTHER PIECE OF EQUIPMENT GO TO THE BEEKMAN FIRE DISTRICT FOR THE CELEBRATION OF COMMISSIONER KEN MALLEN'S 100<sup>TH</sup> BIRTHDAY ON SATURDAY, JANUARY 16<sup>TH</sup>. SECONDED BY COMMISSIONER JODLOWSKI AND CARRIED.

THE CHIEF ADVISED THE BOARD THAT SINCE CHIEF SALTZBURG IS THE INFECTIOUS CONTROL OFFICER HE WILL BE HANDLING ALL INFORMATION REGARDING COVID AND THE VACCINE. CHIEF SALTZBURG WILL KEEP CHIEF LACALAMITA INFORMED AND ALL QUESTIONS REGARDING COVID WILL BE DIRECTED TO CHIEF SALTZBURG. CHIEF LACALAMITA ADVISED THE BOARD THAT INSTEAD OF HAVING A DISTRICT CHAPLAIN HE WOULD RATHER HAVE THE CHAPLAINS FROM EACH STATION HANDLE ANYTHING THAT A DISTRICT CHAPLAIN WOULD. THE BOARD AGREED WITH THIS DECISION

THE CHIEF ALSO ADVISED THE BOARD THAT THE 2020 REPORTS HAVE ALL BEEN SUBMITTED TO COUNTY. HE ALSO ADVISED THAT HE AND CAR 8 ARE WORKING ON SCHEDULING 2021 OSHA CLASSES AND WOULD LIKE TO SEE MEMBERS USE THE ON-LINE LEARNING FOR THE CLASS.

THE BOARD WAS ADVISED BY THE CHIEF THAT JOHN ZBOINSKI WILL BE THE CAPTAIN OF THE FIU IN 2021 AND KARL VOLLMER WILL BE LIEUTENANT.

CHIEF LACALAMITA ASKED THE BOARD TO CONSIDER FORMING A COMMITTEE TO START LOOKING AT GETTING A NEW AMBULANCE, POSSIBLY TWO. IN ADDITION, HE WOULD LIKE THE BOARD TO CONSIDER REPLACING THE PICK UP TRUCKS AS THEY ARE AGING. COMMISSIONER EHRHART STATED THIS WAS THE YEAR THAT WAS DECIDED TO START LOOKING INTO A NEW AMBULANCE AND THEY WANTED TO BE SURE TO CHANGE TO THE PICK UP STYLE. COMMISSIONER DIXON MADE A MOTION TO CREATE AN AMBULANCE COMMITTEE. SECONDED BY VICE-CHAIRMAN SHULTIS AND CARRIED.

FIRST ASSISTANT CHIEF JACKSON ADVISED THE BOARD THAT HE MET WITH ALL THE COMPANY CHIEFS. IT WAS DECIDED THAT THE JANUARY DISTRICT DRILL WILL BE CANCELLED DUE TO COVID, BUT HE ENCOURAGED THE COMPANY CHIEFS TO DO TRAINING AT THEIR STATIONS. CHAIRMAN McNAMARA ASKED CHIEF SALTZBURG WHERE THE COVID NUMBERS ARE AT AND WAS ADVISED THAT THEY ARE GOING DOWN. CHIEF SALTZBURG REQUESTED COMMISSIONER DIXON REACH OUT TO TEK MEDICAL TO REQUEST ALL PHYSICALS BE FAXED TO HEADQUARTERS AS SOON AS THEY ARE COMPLETED, RATHER THAN HOLD THEM UNTIL THE BILING IS COMPLETED. CHIEF SALTZBURG ADVISED REGULAR CREWS ARE BACK WORKING AT EMSTAR AND THEY ARE BACK ON TRACK RESPONDING.

LT VOLLMER ADVISED THE BOARD THAT THE NEW FIU 39-56 IS AT HOPEWELL FIRE APPARATUS GETTING WORK DONE AND THE ANTENNAS AND CAMERAS WILL BE INSTALLED BY GOOSETOWN. HE ASKED IF THE DECAL FROM STREUBER SERVICES HAD BEEN APPROVED AND COULD MOVE FORWARD. THERE WAS DISCUSS REGARDING USING STREUBER SERVICES. ATTORNEY MACLEOD ADVISED THE BOARD THAT SINCE THE OWNER OF STREUBER SERVICES IS 17 YEARS OLD HE IS NOT LEGAL AGE TO ENTER INTO CONTRACT WITH THE EAST FISHKILL FIRE DISTRICT SO IT IS NOT A LEGAL ACTION TO USE STREUBER SERVICES. LT VOLLMER WAS ADVISED THAT THERE IS A RECALL ON 39-56.

CAPTAIN DEVAN GEHRLEIN ADVISED THE BOARD THAT THE GLASS FOR THE 9/11 MEMORIAL CASE WILL BE \$3,365.00 WITH A \$125.00 CRATE FEE, WHICH IS MORE THAN ORIGINALLY APPROVED. COMMISSIONER DIXON MADE A MOTION TO APPROVE THE PURCHASE OF THE GLASS FOR THE 9/11 MEMORIAL CASE AT A COST NOT TO EXCEED \$3,600.00. SECONDED BY COMMISSIONER EHRHART AND CARRIED. CHAIRMAN McNAMARA STATED HE WOULD WORK ON THE THANK YOU LETTER AND PLAQUE FOR THE COMPANY THAT DONATED THE 9/11 MEMORIAL CASE.

CAPTAIN ZBOINSKI ASKED THE BOARD IF WE WOULD BE REIMBURSED MILEAGE SINCE THERE IS NO LONGER A CHIEF CAR FOR THE FIU. CHAIRMAN McNAMARA ADVISED THAT NO ONE IN THE DISTRICT GETS REIMBURSED FOR TRAVELING TO CALLS.

BRUCE PAUBST, ON BEHALF OF MARCO, THANKED THE BOARD FOR THE ACCEPTANCE OF THEIR BID AND ARE HONORED TO BE WORKING WITH THE EAST FISHKILL FIRE DISTRICT.
