The East Fishkill Board of Fire Commissioners held their regular board meeting at district headquarters. Chairman Shultis called the meeting to order at 8:30 P.M.

Bank statements were opened by Vice-Chairman McNamara.

On a motion by Commissioner Post and seconded by Commissioner Stuart, the bills payable as presented were approved, holding Finehand Signs until they are contacted. Motion carried.

Motion carried. Commissioner Stuart made a motion to allow up to 12 members to attend a November 15 EMS Conference @ Grandview at a cost of \$35.00 each. Seconded by Commissioner Ehrhart and carried.

NEW BUSINESS:

Commissioner Post made a motion to allow 3 members to attend Montour Falls for 4 weekends starting in March, 2018 for the Fire Investigator 2 class at \$527.00 per person. Seconded by Vice-

Chairman McNamara and carried. On a motion by Commissioner Post and seconded by Vice-Chairman McNamara, Ben Lederman will be allowed to stay on the district rolls as an out of district member. On a motion by Commissioner Post and seconded by Vice-Chairman McNamara, Ben Lederman will be allowed to attend Montour Falls 11/27 – 12/1 for a HazMat class, to include meals, lodging, and travel. Commissioner Stuart made a motion to allow the companies to use district equipment with the permission of Chief Geysen for their Santa runs this year. Seconded by Commissioner Post and carried. On a motion by Commissioner Post and seconded by Commissioner Stuart, the supplies required to become an AHA training site will be purchased at a cost of not to exceed \$3,500, but there will be additional costs at a later time. Commissioner Post made a motion to accept the bid from Sun-Up as long as they adjust off the tack coat, and increase the asphalt to 2", as long as it doesn't exceed \$69,900. If it does, the bid will go to Clove. Seconded by Commissioner Ehrhart and carried.

Motion to adjourn was made at 8:49 PM by Commissioner Post and seconded by Commissioner Stuart.
