A motion was made by Vice-Chairman McNamara and seconded by Commissioner Ehrhart to authorize the purchase of an Ultra Training Station at a cost of \$3,420.00. Motion carried.

Commissioner Post made a motion authorizing the Stormville Fire Company events for the rest of the year. Seconded by Commissioner Ehrhart and carried.

On a motion by Vice-Chairman McNamara and seconded by Commissioner Ehrhart, the replacement Hurst tool purchase for Co. 4 at a cost of \$9,131.25 was approved.

Vice-Chairman McNamara made a motion to authorize the purchase of five AED's in the amount of \$595.00 each. Seconded by Commissioner Post and carried.

On a motion by Vice-Chairman McNamara and seconded by Commissioner Post, Stormville's use of the bays for their craft fair was approved.

The Town has requested the use of the building in January 2017 on a Saturday for their AED/CPR class. This was approved on a motion by Vice-Chairman McNamara and seconded by Commissioner Post as long as there were no conflicts with district training.

Vice-Chairman McNamara made a motion to host "LP Gas for Firefighters" 12/6 w/60 attendees at no cost. Seconded by Commissioner Post and approved.
