The Board will discuss all nominated candidates that do not have the necessary qualifications at that meeting. If the member is approved, they will be accepted at the January 8<sup>th</sup> meeting.

First Assistant Chief Elect Dan Jackson, Jr advised the Board that he is looking forward to his new position in 2024.
