Commissioner Post made a motion that the H.A. Schreck Annual Maintenance Agreement at Level 2 be signed after the Chairman reviews it and the incident at the radio tower. Seconded by Commissioner Stuart and carried. On a motion by Commissioner Post and seconded by Commissioner Ehrhart the Stormville Fire Company will be authorized to hold their Palm Sunday breakfast. On a motion by

Commissioner Post and seconded by Commissioner Ehrhart the Putnam County Corrections will be allowed to use the facility on May 14, 16 & 18. Commissioner Post made a motion to allow a member to attend Montour Falls on 3/24 for the Hazardous Material Tech 3 course. Seconded by Commissioner Stuart. Commissioner Post made a motion that pending the successful completion of a Permissive Referendum, a 2019 Brush Truck will be purchased and paid for in, an amount not to exceed \$100,000, from the Reserve Fund for Major Equipment. Seconded by Commissioner Stuart. Chairman Shultis asked that the Board be polled:

Commissioner Ehrhart – aye Commissioner Post – aye Commissioner Stuart – aye Chairman Shultis – aye

Motion carried. Commissioner Post made a motion to transfer \$100,000 from the General Fund to the NYCLASS fund. Seconded by Commissioner Stuart and carried.
