All voted in favor. On a motion by Commissioner Post and seconded by Commissioner McNamara, the Mobile Life Support ALS contract for 2018 will be renewed at a cost of \$74,948.64. Motion carried. Commissioner Post made a motion to pay the invoice for Mid-Hudson Construction for the building work, not to exceed \$10,000.00 Seconded by Commissioner Stuart and carried.
