### **UNFINISHED BUSINESS:**

Commissioner Ehrhart made a motion that, subject to a successful permissive referendum, three replacement chief vehicles will be purchased from Beyer Ford. Seconded by Commissioner Post and carried unanimously. Vice-Chairman McNamara made a motion to accept the proposed 2018 budget in the amount of \$3,257,289.00, with the tax levy to be \$3,245,048. Seconded by Commissioner Post. Chairman Shultis asked that the Board be polled:

Commissioner Post - aye

Commissioner Stuart - ave

Chairman Shultis - aye.

Motion carried. This does not exceed the tax cap. Vice-Chairman McNamara made a motion to pass a resolution as attached to these minutes, to hold a Public Hearing on October 17, 2017 at 6:00 PM at Fire District Headquarters for the creation of a special Fire District Tax Zone. Seconded by Commissioner Post. Chairman Shultis asked that the Board be polled:

Commissioner Ehrhart – aye Commissioner McNamara – aye Commissioner Post – aye Commissioner Stuart – aye Chairman Shultis – aye.

Motion carried.

### **NEW BUSINESS:**

On a motion by Vice-Chairman McNamara and seconded by Commissioner Post, the budget items for Co 1, 2, 4 and FIU were approved for purchase. Vice-Chairman McNamara made a motion to purchase 6 Vertex Portable radios per 39-1's request. Seconded by Commissioner Ehrhart and carried.

Chief Geysen stated the antenna is broken for the Bullex system and the burn crib still needs to be replaced. Chairman Shultis said he will write a letter.

1<sup>st</sup> Assistant Chief Lacalamita asked about the True Fuel. The Board it could be purchased and given to the stations. They may need additional storage cans for it. 39-2 said they are at the 10 year mark for some of the bailout equipment. He would also like to see portable radios for every interior firefighter. Commissioner Post said that has been discussed and that's why there are radios on every rig. Chief Lacalamita will put together a gear committee. He stated the FIU is looking to purchase a drone. It will probably go in a locked cabinet on 39-67 with limited access to the keys.

Rescue Chief Saltzburg stated there is a class action suit against the epi-pen manufacturer for price gouging. The District may want to look into it.
