Commissioner Ehrhart made a motion to purchase the additional budget items requested by Station 2 in the amount of \$2,210.00. Seconded by Vice-Chairman Shultis and carried.

Commissioner Post made a motion to authorize the Treasurer to transfer \$50.000.00 from Mahopac MM to Mahopac Checking. Vice-Chairman Shultis seconded. Motion carried.

Commissioner Stuart made a motion to allow and cover the tag sale at Stormville on 10/13/2019. All Commissioners were notified prior to the event. Seconded by Commissioner Ehrhart and carried.

1st Assistant Chief Lacalamita advised the Board that he has been offered a house on Hillside Lake Road to use for training for the next year. He will not be doing any live burns at the house, as it is too close to other homes. The Board will allow this as long as proof of ownership from Habitat for Humanity is provided, in addition to liability insurance.
