MEETING OPENED:

The East Fishkill Board of Fire Commissioners held their budget hearing and regular meeting at District Headquarters. Chairman Shultis opened the meeting with the Pledge of Allegiance at 7:03pm.

A motion to open the public hearing for the 2019 budget was made at 7:04pm by Commissioner Ehrhart and seconded by Commissioner Stuart. Chairman Shultis asked those in attendance if there were any questions. John Paraskeva questioned the increased in the ambulance budget line. Chairman Shultis advised the District is now paying for both an ALS and a BLS ambulance to Mobile Life. John Paraskeva also inquired about the balances of the reserve accounts. Commissioner Ehrhart advised him that there were several large equipment purchases coming, ie: ladder truck, two engines. The Board advised that the budget was kept below the 2% tax cap.
