MEETING OPENED:

The East Fishkill Board of Fire Commissioners held their regular board meeting at headquarters. Chairman McNamara called the meeting to order at 8:00 P.M.

SECRETARY'S REPORT:

The minutes of the November 29, 2021, and December 13, 2021 meetings were accepted on a motion by Commissioner Jodlowski and seconded by Commissioner Dixon. Motion carried.

The Treasurer's Report for November 2021 was accepted on a motion by Commissioner Dixon and seconded by Commissioner Jodlowski. Motion carried.

NEW BUSINESS:

Commissioner Ehrhart made a motion to purchase 21 Support Group jackets at a cost not to exceed \$1,500.00. Seconded by Commissioner Dixon and carried.

Commissioner Ehrhart made a motion to accept the Empress contract, with the amendments, and to have the Vice-Chairman sign it. Seconded by Commissioner Dixon and carried.

Commissioner Ehrhart made a motion to purchase new bunker pants for a member that were deemed condemned. Seconded by Commissioner Dixon and carried.

Commissioner Ehrhart made a motion to purchase three Thermal Imagining Camera's, at the request of Car 1, at a cost not to exceed \$9,000.00. Seconded by Commissioner Jodlowski and carried.

Commissioner Ehrhart made a motion to allow up to 10 EMS members to attend a seminar in Sheldon on January 29, 2022. The cost is \$20/per person and they will be requesting transportation. Seconded by Commissioner Jodlowski and carried.

Commissioner Dixon made a motion to allow two members of the Fire Investigation Unit to attend the IAAI conference in Jacksonville, FL in April. Seconded by Commissioner Ehrhart and carried.

Commissioner Dixon made a motion to allow two members to attend two NYS courses in Westchester County in early 2022 at no cost to the District. Seconded by Commissioner Jodlowski and carried.

Commissioner Dixon made a motion to allow one member to attend NYS Fire Academy in March 2022 for NYS Fire and Emergency Service Instructor II. Seconded by Commissioner Jodlowski and carried.

Commissioner Dixon made a motion to purchase, from Scanga Innovative Woodwork, the interview bench and table for the new 39-56 at a cost of \$2,500.00. Seconded by Commissioner Jodlowski and carried.

Commissioner Dixon made a motion to allow the meeting room to be used by IAAI on February 7, 2022 and to provide lunch at a cost not to exceed \$300.00. Seconded by Commissioner Ehrhart and carried.

Commissioner Dixon made a motion to purchase a replacement mat for the bail out window in the amount of \$1,239.27. Seconded by Commissioner Ehrhart.

Commissioner Dixon made a motion to order and have installed, by JP Graphics, the lettering for the new 39-56 in the amount of \$3,750.00. Seconded by Commissioner Jodlowski and carried.

DISTRICT CHIEF: See Report

- 1. Chief Lacalamita advised the Board that the camera system is no longer working on his computer. O'Tooles Security will need to be contacted.
- 2. He advised that there has been training on the new 39-46 and that it does need new decals. Vice-Chairman Shultis stated that the members of Station 1 have done a great job getting it ready. JP Graphics will take a look at it when they are here on Friday. He also advised that tools still need to be mounted.
- 3. 39-52 will be in service soon and 39-41 is still being worked on.
- 4. There was discussion regarding Chief Lacalamita's request to have the Board consider lowering the age a member begins to collect LOSAP and possibly increasing the dollar amount. He was advised that the money currently in the account covers the current members collecting and there is not additional money to be put towards this.

1st ASSISTANT CHIEF: See Report

Chief Conti requested being put on the agenda for the next workshop.

Karl Vollmer stated that 39-56 is taking a while to complete but they are saving the District money by doing most of the work themselves. Chairman McNamara stated he will get a date for the lettering after January 1, 2022.

Commissioner Ehrhart requested a discussion regarding the mask policy going forward. Per Attorney McLeod, any policy the Board decides on may have exceptions, ie: the office staff does not have to wear masks when alone in the office. The Board will discuss this further.

Motion to adjourn was made at 8:30 P.M. by Commissioner Dixon and seconded by Chairman McNamara.


