MEETING OPENED:

SECRETARY'S REPORT:

The minutes of the September 22, 2021, October 12, and October 19, 2021 meetings were accepted on a motion by Commissioner Dixon and seconded by Commissioner Ehrhart. Motion carried.

TREASURER'S REPORT:

The Treasurer's Reports for September 2021 was accepted on a motion by Commissioner Jodlowski and seconded by Commissioner Dixon. Motion carried.

BILLS PAYABLE:

Commissioner Jodlowski made a motion that the bills payable from the General Fund totaling \$151,751.91, \$17,851.28 from the Reserve for Building & Land, \$1,514,943.95 from the Reserve for Major Equipment, all numbered 1073 through 1214 be approved. Seconded by Commissioner Ehrhart and carried.

COMMUNICATIONS:

- 3. Resignation letter from Scott Birkler from the District.

UNFINISHED BUSINESS:

On a motion by Commissioner Dixon and seconded by Commissioner Jodlowski, the 2022 budget was approved as proposed for a total of \$3,656,592.00, of which \$3,614,232 is to be raised by taxes. Chairman McNamara asked to poll the Board:

Commissioner Dixon – aye

Commissioner Ehrhart - aye

Commissioner Jodlowski – aye

Chairman McNamara – aye

Motion carried.

Commissioner Jodlowski made a motion for a resolution to set November 29th from 9 AM to 12 PM for the preparations of the registrations rolls. Seconded by Commissioner Dixon and carried.

On a motion by Commissioner Jodlowski and seconded by Commissioner Ehrhart, a resolution for the hiring of the Election Chairperson and clerks for December 14th at a fee of \$70.00 each. Motion carried.

Commissioner Jodlowski made a motion to approve the purchase of 55 desktop Vertex Chargers for a total of \$2,376.00. Seconded by Commissioner Dixon and carried.

On a motion by Commissioner Ehrhart and seconded by Commissioner Jodlowski, Paul Roughgarden's termination was rescinded. Motion carried.

NEW BUSINESS:

On a motion by Commissioner Jodlowski and seconded by Commissioner Dixon, pending the successful completion of a permissive referendum, \$500,000 has been authorized to be spent out of the Reserve Fund for Major Equipment for the purchase of a pumper/tanker.

Commissioner Jodlowski made a motion to authorize ESS to do the work on the radio tower antenna system for \$7,424.00. Seconded by Commissioner Ehrhart and carried.

Commissioner Jodlowski made a motion to transfer \$100,000 from NYClass General Fund to Mahopac Checking. Seconded by Commissioner Ehrhart. Commissioner Dixon abstained and all others voted aye. Motion carried.

On a motion by Commissioner Dixon and seconded by Commissioner Ehrhart, the new 39-52 was accepted.

On a motion by Commissioner Dixon and seconded by Commissioner Jodlowski, \$1,025,952.00 including wire fees if necessary, and \$488,558.00, including wire fees if necessary, is authorized to be wired from NYClass Fund for Major Equipment to Marion Body Works for the payment of three chassis and the new Rescue Truck respectively. All voted in favor and motion carried.

DISTRICT CHIEF: See Reports for September as attached.

- 1. Chief Lacalamita stated 39-81 is temporarily located at the Stormville Substation.
- 2. The 30 minute bottle borrowed from MES is going back, but will be signed back out to East Fishkill. The Chief is still waiting on a price estimate for the purchase of 40 new bottles.
- 3. There is a Brush Truck Committee meeting on 11/17.
- 4. Commissioner Jodlowski stated the Board has signed the agreement with New Hyde Park for the used aerial and are waiting for the results of the ladder and bucket testing.
- 5. The FIU vehicle is coming together.
- 6. Chief Lacalamita asked if the overheating problem with the six wheeler has been repaired. Secretary Beyer said there was no paperwork on it, so nothing has been done. 1st Assistant Chief Jackson will write something up.
- 7. Amazon has been very receptive to things the Fire District has requested and the Chief would like to do a walk through at the location.

- 8. As of now, there are only 2 people signed up for FDIC. Secretary Kaye will put it out again with a response by date of 11/30/21.
- 9. The CAD system will be updating on 11/8 at 6 AM.
- 10. Chief Lacalamita asked the status of the Bullex system. Commissioner Ehrhart stated we are waiting for a letter from the attorney to them. He stated they should continue to use it as they have been, but the Board is looking into getting a temperature sensor system for the training center. Commissioner Dixon stated they are also looking to replacement of some big tiles.

1st ASSISTANT CHIEF: See Report for September as attached.

1. Commissioner Jodlowski said he has been looking for a mat for bailout, but hasn't found anything yet.

Assistant Chief Conti stated he has worn the 30 minute bottle a few times and there is an amazing difference between it and the current bottles we have. He had no back pain and it has a sleeker profile.

Assistant Chief Gallo stated the aprons and paving are done at the substation. He thanked everyone for their work on the new 39-52. He requested an executive session after the meeting.

Assistant Chief Kuhl asked if anything further had been done on the hose dryer.

Captain Zboinski stated the new FIU vehicle is 90% done inside. They are working on the lettering ideas. They are also waiting for the bench maker to come back with an estimate. Commissioner Dixon expressed his thanks to all who have worked so much on this on their own time.

Commissioner Dixon stated that Chief Gallo will meet with Bruce Paupst to discuss where tools will be mounted. District Chief Lacalamita would like to be included in that meeting.

Motion to adjourn to executive session was made at 8:34 PM by Commissioner Dixon and seconded by Commissioner Ehrhart.

EXECUTIVE SESSION:

At 8:34 PM, the Board and Chief Gallo met to discuss the status of P. Roughgarden and Chief Gallo will get back to the secretaries tomorrow to let them know if he has been dropped from the station.

Motion to adjourn executive session was made at 8:40 PM by Chairman McNamara and seconded by Commissioner Jodlowski.


