March 27, 2019

MEETING OPENED:

The East Fishkill Board of Fire Commissioners held their regular board meeting at district headquarters. Chairman McNamara called the meeting to order at 7:35 P.M.

MEMBERS PRESENT:

Those members present were: Chairman McNamara, Vice-Chairman Shultis, Commissioner Ehrhart and Commissioner Stuart. Commissioner Post was excused.

All motions were unanimous, unless otherwise stated.

MOMENT OF SILENCE: For all fallen brothers and sisters in the military, police, and fire service.

BID OPENING:

Bids were received and opened for the advertised natural gas generator. Bidders were as follows:

After a detailed review of the bids and comparisons between them and the specs, a motion was made by Commissioner Ehrhart and seconded by Vice-Chairman Shultis to accept the bid from Alliance Electric with the service rated transfer switch and the labor at a cost of \$50,439.00, of which \$19,500 is labor. Motion carried.

Commissioner Ehrhart made a motion to suspend the meeting at 8:01 and it was seconded by Commissioner Stuart.

At 8:30 Commissioner Ehrhart made a motion to resume the meeting. Seconded by Commissioner Stuart and carried.

SECRETARY'S REPORT:

The minutes of the February 27th meeting and the March11th meeting and SAC meeting were accepted on a motion by Commissioner Stuart and seconded by Vice-Chairman Shultis. Motion carried.

TREASURER'S REPORT:

The Treasurer's Reports for February 2019 was accepted on a motion by Commissioner Ehrhart and seconded by Vice-Chairman Shultis. Motion carried.

BILLS PAYABLE:

Commissioner Ehrhart made a motion that the bills payable from the General Fund totaling \$233,869.13 and \$2,500.00 from the Reserve Fund for Building & Land, numbered 270 through 461 be approved. Seconded by Commissioner Stuart and carried.

On a motion by Vice-Chairman Shultis and seconded by Commissioner Ehrhart, these applications, pending physicals were approved.

DRIVER/TRAINING APPLICATION:

COMMUNICATIONS:

- 1. Request to change the Blood Drive date from 9/28 to 9/7.
- 2. Letter from Shenandoah Contractors regarding the annual air compressor maintenance.

UNFINISHED BUSINESS:

Commissioner Ehrhart made a motion that the building to may be used for a blood drive on September 7th instead of September 28, as long as there are no conflicts. Seconded by Commissioner Stuart and carried.

Commissioner Ehrhart made a motion to drop Corey Ricotta due to no physical and being on Administrative Leave since February. Seconded by Commissioner Stuart and carried.

On a motion by Commissioner Ehrhart and seconded by Vice-Chairman Shultis, two ISG Thermal Imaging Cameras will be purchased from Hi-Tech at a cost of \$8,335.80 each. Motion carried.

NEW BUSINESS:

On a motion by Commissioner Stuart and seconded by Vice-Chairman Shultis, Shenandoah Contractors will do the annual air compressor maintenance. Motion carried.

On a motion by Commissioner Stuart and seconded by Vice-Chairman Shultis, HA Schreck is authorized to do the annual maintenance on all the emergency generators at HQ and the stations at a Level 1 & Level 2, and authorize the Chairman to sign the agreement.

Commissioner Stuart made a motion to rebalance the LOSAP accounts per the recommendation of Morgan Stanley. Seconded by Vice-Chairman Shultis and carried.

On a motion by Commissioner Stuart and seconded by Commissioner Ehrhart a member was authorized to attend Haz Mat training at Montour Falls. Motion carried.

Commissioner Ehrhart made a motion to rescind the approval of the proposed Station 3 member for further discussion. Seconded by Commissioner Stuart and carried. He asked for an executive session to discuss a personal issue.

DISTRICT CHIEF:

Chief Geysen was excused.

1st Assistant Chief Lacalamita was excused.

Chief Conti stated they have members that were invited to Inwood for their installation dinner and would like permission to use the district chief's car for the transportation. This was approved on a motion by Commissioner Ehrhart and seconded by Commissioner Stuart. Chief Conti asked what was covered during the Plymovent maintenance and Chairman McNamara reviewed the list. Chief Conti stated that the tube for 39-46 is not in use and the Plymovent for the ambulance doesn't get used either.

Chief Gallo asked to make sure that when Plymovent does come in, they leave a drawing of where the vents will be located to make sure there are no warrantee issues. He also said to be sure that the mechanic knows there is stuff in the basement. They are hoping to get their Certificate of Occupancy soon.

Chief Kuhl asked that when Plymovent arrived to do the maintenance, he would like to be there.

Chairman McNamara stated Hopewell Fire Apparatus did a great job on the brush truck.

ADJOURNMENT:

Motion to adjourn to executive session was made at 9:04 PM by Commissioner Ehrhart and seconded by Commissioner Stuart.

EXECUTIVE SESSION:

At 9:10 PM executive session was called to order by Chairman McNamara.

There was discussion regarding a past member. At 10:15 Commissioner Stuart made a motion to adjourn the executive session. Seconded by Commissioner Ehrhart and carried.

Commissioner Ehrhart made a motion to deny the membership application for Station 3, Devin Morelli. Seconded by Vice-Chairman Shultis and all were in favor. Motion carried.

Secretary Beyer asked if it was ok to use the house DJ and photo booth for the inspection dinner and the Board said yes.

It was decided that 39-1 was to use an Uber to get to the airport for FDIC.

Secretary Beyer stated there have been some checks received from the recruitment letter. The Board decided these will be divided between the stations.

Motion to adjourn was made at 10:18 PM by Commissioner Ehrhart and seconded by Commissioner Stuart.
