# **UNFINISHED BUSINESS:**

### **NEW BUSINESS:**

Same member allowed to take the Live Fire Instructor course at Montour Falls August 26-27, 2022 to include registration and lodging fees. Seconded by Vice-Chairman Ehrhart and carried.

Commissioner McNamara made a motion to transfer \$100,000 from NYClass General fund to Tompkins Checking. Seconded by Commissioner Jodlowski. Commissioner Dixon abstained. All others voted aye. Motion carried.

Chief Lacalamita advised the Board that he is working on a date in August for Appreciation Day that will not conflict with the Dutchess County Fair. Station 1 will be doing a birthday drive by on June 25<sup>th</sup> at Sunset Blvd. At the request of the American Legion, Station 1 will be at their flag burning, behind the library on June 14<sup>th</sup> at 8pm. A fireworks detail for the town will be on July 1<sup>st</sup>. The Town Supervisor has advised that in the event of a large emergency he would allow members who are employed by the town, as well as town workers that are qualified firefighters, to leave work to assist at the event.
