MEETING OPENED:

The East Fishkill Board of Fire Commissioners held their regular board meeting at headquarters. Chairman McNamara called the meeting to order at 8:00 P.M.

MEMBERS PRESENT:

Those members present were: Chairman McNamara, Commissioner Ehrhart, Commissioner Dixon, and Commissioner Jodlowski. Vice-Chairman Shultis was excused.

All motions were unanimous, unless otherwise stated.

MOMENT OF SILENCE: For all fallen brothers and sisters in the military, police, and fire and EMS service.

SECRETARY'S REPORT:

The minutes of the May 26, 2021, and June 14, 2021 meetings were accepted on a motion by Commissioner Dixon and seconded by Commissioner Jodlowski. Motion carried.

TREASURER'S REPORT:

The Treasurer's Reports for May 2021 was accepted on a motion by Commissioner Jolowski and seconded by Commissioner Dixon. Motion carried.

BILLS PAYABLE:

Commissioner Dixon made a motion that the bills payable from the General Fund totaling \$266,565.24, to include \$3,250.00 for Theodore Eglit, CPA, and \$1,390.15 from the Reserve for Building & Land, all numbered 580 through 688 be approved. Seconded by Commissioner Ehrhart and carried.

On a motion by Commissioner Ehrhart and seconded by Commissioner Dixon this application, pending receipt of physical, was approved.

UNFINISHED BUSINESS:

Commissioner Jodlowski made a motion to rescind the prior motion having Precision Auto repair 39-13. Seconded by Commissioner Ehrhart and carried. This will be done by maintenance.

On a motion by Commissioner Ehrhart, the purchase of panels, trim, and screws from Stage Door Supply, not to exceed \$2,500.00 was approved. Seconded by Commissioner Dixon and carried.

Commissioner Jodlowski made a motion to authorize Precision Auto's repair of 39-63 in the amount of \$2,872.50. Seconded by Commissioner Dixon and carried.

NEW BUSINESS:

On a motion by Commissioner Jodlowski and seconded by Commissioner Dixon, the use of the building by the Town on August 17, 2021 was approved.

Commissioner Jodlowski made a motion to transfer \$10,000 from Mahopac Checking to Mahopac Business Builder and \$774.97 from Mahopac Checking to Mahopac Trust and Agency for the NYS-1 payment. Seconded by Commissioner Ehrhart and carried.

Commissioner Jodlowski made a motion to accept the 2020 Fiscal Year Report as prepared by Theodore Eglit, CPA and authorize the Treasurer to mail a copy to the State Comptroller. Seconded by Commissioner Dixon and carried.

DISTRICT CHIEF: See Reports for May as attached.

- 1. Chief Lacalamita stated the fuel tank alarm is going off. Secretary Beyer stated Optimum Environmental has been called and will be here as soon as possible.
- 2. Monday night East Fishkill Magazine was here to do an interview and take pictures. They seemed very impressed and took a lot of pictures.
- 3. 39-1 and 39-2 went to GlobalFoundries to see how they train and to speak with Chief Renahan regarding fire protection at the site. Chief Renahan stated they are just responding to GlobalFoundries, not to any other businesses at that sight. Assistant Chief Gallo said if someone calls 911 from their cell phone while on site, EFFD will probably be dispatched.
- 4. Appreciation Day is August 21st. He would like a signup sheet on the website.
- 5. Chief Lacalamita asked what the status of 39-46 was. Chairman McNamara stated people are being deposed from July to August. Attorney MacLeod stated if it goes to trial it could be two years. Commissioner Ehrhart said the truck will never be used again, but 39-3 was told at inspection to take it out and run the ladder up every once in a while and to film it just in case it drops again. The Board will not be moving that truck out of the station as there is nowhere to put it. Steve Conti asked if there was any thought to renting or leasing a ladder in the meantime. Commissioner Ehrhart stated it is being discussed.

1st ASSISTANT CHIEF: See Report

1. Chief Jackson stated there is a firefighter interested in a survival class being given in Putnam County. It is at no cost. This is happening more often as there aren't a lot of classes being given in Dutchess County right now.

Chief Gallo stated there is an issue with the Rail Trail Crossing at Route 216. When you approach with a larger vehicles it seems to trip the warning lights signaling that someone is crossing the road. There are also a lot of bicycles not stopping before they cross the road, so everyone needs to be alert.

Chairman McNamara stated the 6-wheeler trailer is going out for maintenance. There is a lot of activity going on at the Amazon site. There are 30 foot walls going up and it appears that Building 630 has been demolished.

Ben Howell asked if the workshop meetings could be held in the meeting room. Chairman McNamara stated the Board has already discussed this and it was decided that they will be in the meeting room going forward. Commissioner Ehrhart said that the exception would be for executive sessions. Firefighter Howell also asked if the Board would be open to consider changing the night of the workshop meeting as it is a drill night.

Craig Paupst asked who is getting the tax money for the Amazon sight if everyone thought GlobalFoundries was the responding agency. Attorney MacLeod stated EFFD was getting the tax funds.

Firefighter Conti asked if there was a proposed date that the new building would be available for use for training. Chairman McNamara stated there are no lights in yet, but the electricians are there working this week. There is also a ventilation system to go in, but it should be useable soon.

ADJOURNMENT:

Motion to adjourn to executive session for a personnel discussion was made at 8:35 PM by Commissioner Dixon and seconded by Commissioner Jodlowski.
